# ELIGIBILITY AND HOW TO ENTER

#### ELIGIBILITY

The competition is open to all Australian packaging and label converters. All entries must be accompanied by the respective entry clearly identifying the different print parameters described in the Entry Form. The printed material must be manufactured in Australia.

#### **BENEFITS OF ENTERING**

- Industry recognition for achieving the highest standard of printed packaging.
- All winning entries will be published in Australia's leading magazines.

#### **HOW TO ENTER**

#### READ THE ENTRY DETAILS CAREFULLY

- Read the entire entry form and ensure that the definitions and entry criteria are clearly understood.
- Entries MUST have been produced between 1st July 2021 and 30th June 2022.
- Submitted entries MUST be manufactured in Australia and are for commercial use.
- Each submission must be accompanied by a separate entry form and be accompanied as follows:

#### LABELS

25 un-mounted samples, either in continuous form for roll-to-roll entries, or full sheets in the case of sheet fed labels. Submissions with less than 25 labels or where substitution of labels is observed by the judges, will be disqualified.

#### FLEXIBLE PACKAGING

10 consecutive print repeats. Samples must not be cut or trimmed. Submissions with less than the required repeats will be disqualified.

#### CARTONS

10 consecutive repeats of the finished carton. Submissions with less than the required repeats will be disqualified.

#### POSTPRINT

10 consecutive repeats of the finished carton. Submissions with less than the required repeats will be disqualified.

#### PREPRINT

10 consecutive repeats. Submissions with less than the required repeats will be disqualified.

#### ENVELOPE

10 consecutive repeats of the finished envelope. Submissions with less than the required repeats will be disqualified. • All winning entries will be entered into internationally recognised packaging competitions including where applicable the World Label Awards and/or the FFTA Awards.

Each company may enter as many categories as they choose.

- Provide the judging panel with as much information as possible.
- Each submission may only be entered in one category of the converter's choosing.
- Companies are limited to two entries per category.
- Wine and Spirit labels will only be accepted into the relevant category for Wine and Spirits. They will NOT be accepted into any other category
- The name of the converter must NOT appear on any of the submitted printed material or label or it will be disqualified.
- Entries may be reclassified at the judges' discretion.
- Reclassified entries will be disqualified if there are already two submitted from your company in the appropriate category.
- Decisions on submitted entries will be at the sole discretion of the judges and no correspondence will be entered into.

The company entering the printed material should obtain the permission of the brand owner before submitting the entry.

Entries are accepted in good faith. FPLMA cannot assume the responsibility for the inclusion of entries not qualified. FPLMA reserves the right to withdraw any award made in violation of competition rules.

All entries submitted will become the property of the FPLMA.

Winning entries will be retained for display purposes and may be used for promotional purposes.

Non-winning entries will be disposed of following the judging.
